Privacy Declaration

MEDPRICE.COM strives to maintain the highest standards for the protection of privacy over the Internet. The purpose of this statement is to explain to you, whether you are a Visitor, program User or an Associate, the type of information **MEDPRICE.COM** obtains about you at our web site, how we gather it, how we use it, how long we retain it, and how you can restrict the use or disclosure of personally identifiable information.

Information We Collect:

The personal information **MEDPRICE.COM** obtains about individual Visitors, program Users, and/or Associates of our web site is information that you supply voluntarily. This means that you can visit our web site without telling us who you are or revealing any information about yourself. To gauge the effectiveness of our web site, we do collect some generic information about our visitors. Our web server automatically recognizes a visitor's domain name (such as .com, .edu, .org, etc.), the web page from which a visitor enters our site, which pages a visitor visits on our site, and how much time a visitor spends on each page. We use web beacons (a.k.a. clear gifs) to track use of our site and to track what sites users came from and go after leaving our site. We do track user activity on sites outside of **MEDPRICE.COM**. We aggregate this information and use it to evaluate and improve our web site.

MEDPRICE.COM may collect personally identifiable information (such as name, email address, postal address) and/or third party personally identifiable information through this web site. You may choose to provide individual information to **MEDPRICE.COM** in a number of ways through our web site such as by:

- Becoming a **MEDPRICE.COM** User;
- Becoming a **MEDPRICE.COM** Associate;
- Sending us e-mail;
- Registering to receive news, public policy updates; or information about our services;
- Applying for a job with **MEDPRICE.COM**.

When Visitors and/or Associates supply information about themselves for a specific purpose, **MEDPRICE.COM** uses the information for that purpose (such as to provide the information the visitor/associate has requested or to consider a visitor/associate for a particular job). When visitors/associates use our web site services, or request information about them, we may use the individual information as we would use the same information obtained off-line- for example,

to evaluate your service needs and contact you regarding additional services you may find useful. You have the right to choose not to receive this information by notifying us of your preference.

When a user wants to set up an account with **MEDPRICE.COM**, in order to determine the user's credit worthiness, we use their name, date of birth, and social security number to request a credit check report from a credit-reporting agency. Once we determine a user's credit-worthiness, this document is destroyed.

We do not sell individual information obtained on-line about our visitors. And, we will not disclose the individual information provided to us on-line to anyone outside of **MEDPRICE.COM** unless you specifically authorize it, it is required by law, or disclosure is necessary to protect the safety of customers, employees or property. If you provide individual information to us in the context of an event or program **MEDPRICE.COM** sponsors with another company, or if you register on a co-sponsored site or feature, you may also be providing the information to the co-sponsor. In those circumstances, the co-sponsor's privacy policy will control, so review their information carefully. **MEDPRICE.COM** from time to time uses third party contractors to perform services such as web site management, site design, site hosting and special promotions but does not use user information for other purposes beyond providing specific services on the **MEDPRICE.COM** web site.

Email:

MEDPRICE.COM does not send unsolicited "junk" email (spam). We may use email to communicate with our customers, to respond to visitor's emails, to confirm transactions placed online, and to send information that a visitor has requested. If you receive an unwanted email from us, you can simply reply to ask us not to receive future emails.

MEDPRICE.COM provides an unsubscribe function in its email campaigns in order for subscribers to opt out of further communications from us.

Use of Cookies:

MEDPRICE.COM web site also uses "cookies". They allow us to serve you better. When you use our site we send information, a cookie, to your computer and it is stored there. When you return to our site, your computer sends the cookie back to us. This allows our server to recognize your computer and any settings you created on your site. It restores those settings so you don't have to enter the same information every time you visit. For example, if you entered your zip code on a visit to our site, when you return you will see information for that zip code without typing it in again. The fact that our server recognizes your computer when it retrieves the cookies does not mean that **MEDPRICE.COM** is actually acquiring information about you. You can set your

browser to delete cookies or tell you before you accept one. Look in your browser's Options or Preferences menu.

Security:

MEDPRICE.COM uses Secure Socket Layer technology with encryption for the transmission of sensitive data such as credit card information and Social Security Number.

MEDPRICE.COM is committed to safeguarding customer privacy on our web site. We require our employees to protect the privacy of information about our customers and expect our Authorized Agents to do so as well. You can feel confident that your individual information will be protected when you access your account or use the services from our web site over the Internet. We employ security measures to safeguard your transactions with us.

Compliance with Laws:

Though we make every effort to preserve user privacy, we may need to disclose personal information when required by law wherein we have a good-faith belief that such action is necessary to comply with a current judicial proceeding, a court order or legal process served on our Web site.

Links to other web sites:

The **MEDPRICE.COM** web site contains links to other sites. We are not responsible for the content or the privacy practices employed by other sites. To improve the services it can offer you, **MEDPRICE.COM** may opt to expand its capabilities for obtaining information about users in the future. **MEDPRICE.COM** will update this privacy declaration continually to ensure that you are aware of developments in this area.

Updating Your Information:

Users may access, correct, and update information they have provided **MEDPRICE.COM** by visiting our site and connecting to our Customer Service Department. Either using the Customer Service link or the Contact Us area of the site will bring up email links by which users can send in information updates.

Notice of Changes:

MEDPRICE.COM will provide 30 days notice on our web site of any material changes to the privacy declaration and in the use of personally identifiable information.
